

Regulation of Ecoclub of Sumgayit State University

1. General provisions

1.1. "Ecoclub" (hereinafter - the Club) created by the department of Ecology of Sumgayit State University (hereinafter - the University) is aimed at forming special knowledge and skills of students in the field of ecological culture and environmental protection, studying the environment, further strengthening environmental education and solving environmental problems. operates in the direction of active involvement of young people;

1.2. The club, as a student organization of the university, is guided by the Constitution of the Republic of Azerbaijan, the Laws of the Republic of Azerbaijan, the Charter of Sumgayit State University and other legal acts;

1.3. While performing its duties, the club interacts with other structural units of the university.

2. Directions of action

2.1. The activities of the club are as follows:

2.1.1. involvement of club members in environmental training;

2.1.2. conducting exhibitions and competitions;

2.1.3. organization of excursions to industrial enterprises, national parks;

2.1.4. Conducting environmental actions in the city of Sumgayit and the university territory;

2.1.5. organization of debates on topics dedicated to environmental protection;

2.1.6. organization of master classes of outstanding environmental scientists;

2.1.7. celebration of ecological calendar days - conducting scientific practical seminars, webinars and other events according to calendar days;

2.1.8. representing the club in local and international environmental activities;

2.1.9. conducting polls dedicated to environmental issues.

3. Objectives and tasks

3.1. The goals of the club are as follows:

3.1.1. increasing environmental awareness among students;

3.1.2. promoting the principles of environmental protection and sustainable development;

3.1.3. development of environmental knowledge and skills;

3.1.4. formation of ecological culture.

3.2. The tasks of the club are as follows:

3.2.1. implementation of environmental education works;

3.2.2. ensuring the spread of the club's reputation among students;

3.2.3. providing coverage of the club's activities;

3.2.4. ensuring the participation of students in university, local and international events.

4. Membership rules, rights and duties

4.1. Club membership rules:

4.1.1. Club membership is carried out on a voluntary basis;

4.1.2. Every student of the university can be a member of the club;

4.1.3. Those who want to become members should fill out the club's official application form.

4.2. Members' rights:

4.2.1. participate in club events;

4.2.2. make suggestions;

4.2.3. take advantage of the opportunities offered by the club;

4.2.4. to take place in the management structure of the club.

4.3. Duties of members:

4.3.1. comply with the club's Regulations;

4.3.2. participate in club activities;

4.3.3. adhere to ecological principles.

5. Management organization

5.1. The management of the club is carried out by the management team;

5.2. The composition of the management team includes the chairman and vice-chairmen elected from among the members, the supervisor elected among the teachers;

5.3. The duties of the management team are as follows:

5.3.1. to organize and control the general activities of the club;

5.3.2. plan and implement events and projects;

5.3.3. promote collaboration and strengthen relationships among members.

6. Final provisions

6.1. Amendments and additions to this Regulation are made according to the legislation of the Republic of Azerbaijan;

6.2. The decision to cancel the club is made at the general meeting and submitted to the university administration;

6.3. This Regulation enters into force from the moment of its adoption and regulates the activities of the club.

The Regulation of the Club was adopted at the meeting of the Scientific Council of the university dated 30.11.2022 (protocol No. 03).
